# Pragmatic approaches to designing and maintaining institutional integrity policies

### Purpose of this study:

Members of the AIPWG / NERQ SIG have organised this workshop.

The recent rapid evolution of artificial intelligence (AI) tools has necessitated rethinking both the scope and nature of institutional policies relating to academic and research integrity globally, which makes this a good time to open conversations about local, national and international requirements.

This topic forms the basis of the workshop that will provide opportunities for participants to review some of the most frequently cited studies on integrity policies in the light of recent developments and their own experiences.

### What are we asking:

The workshop will specifically focus on some or all of these questions:

- 1. What is the advantage of having integrity policies applied consistently across an institution?
- 2. What difference does the adoption of a positive approach based on integrity make to the institutional culture?
- 3. In practical terms, how often should policies be monitored, reviewed and revised?
- 4. Do strong, consistent integrity policies lead to a reduction in the number of integrity breaches?
- 5. How have institutional policies changed in the light of recent AI developments?
- 6. Are there any policies that should be defined at national or even international level?

# How the workshop will be organised:

- Introduction to the workshop and informed consent (5 mins)
- Background to each of the questions (5 mins)
- World Café to discuss each of the questions in parallel (2x10 = 20 mins)
- Feedback from facilitators on discussions (15 mins)
- Plenary discussions and conclusions (5 mins)

The organisation of tables and questions in the World Café will depend on the number of participants in the workshop.

### How we would like to use the information provided:

The information collected from workshop participants will be collected and analysed to produce a narrative description, including some data analytics. The plan is for the authors to have this published in a peer reviewed journal or as a book chapter after the conference.
