- President's Report Karl Hatton
   Summary: Thanks to the committees and chairs for their work for the Chapter. Several have been revamped, rebranded and re-energized and we're seeing the fruits of their labor.
   TERT is a focus to provide training with goal of responding to significant events to help other Centers in times of crisis. Karl spoke of efforts for state-wide certification highlighting contacts with many groups and the need to engage labor, specifically Teamsters.

#### STANDING REPORTS

- Forums Committee Richard Kirton
   Summary: A flyer is at registration table for the Fall Conference. Registration is open at eventleaf.com/pscc. PGAC – Keith Flewelling

Summary: Keith stressed it is important for all labor to be involved in the certification effort. He suggested PSAPs ask their guilds/associations to write a letter of support that can be used with legislators. Karl acknowledged Keith for his good work with the legislative issues including the raising of the 1/10<sup>th</sup> of 1% sales tax.

• SIEC - Keith Flewelling

Summary: State Interoperability Executive Committee is moving from under OCIO to the Military Department. This committee will be expanding to advisory role for all public safety land-mobile-radio in the State; previously the role was for state agencies only and reflects the realization we are a system of systems state-wide. The move to the Military Department is seen as a positive as it puts them under the same structure as the 911 Office.

### **NEW BUSINESS**

• Elections – Karl Hatton

Summary: Elections will be held at the October conference for positions of Vice-President (6-year commitment through cycle), Executive Council Rep (4 years) East-Side Ambassador and Commercial Representative (2 years for each). The Chapter Executive Committee will establish a Nominating Committee with nominations closing on August 31<sup>st</sup>.

Audit Committee – Karl Hatton

Summary: A committee to review the financial operations of both APCO and NENA business was created. Members are Katy Myers, Della Mauler, Mike Rawlings, Mary Sue Robey, Andy Leneweaver and Julie Buck. The goal is to verify the processes and policies are acceptable and to make recommendations on if further review is needed. The committee will report out at the Fall Conference.
