- Article IV, Section 1 lists the requirements for "good standing"
- $\bullet$  Article IV has lots of other good stuff!  $\odot$
- PTAs not in good standing also miss out on other great stuff – like Reflections & Awards

#### False – Review your Bylaws often!

#### Renew

- Done every three years
- Review Bylaws
- Determine there are no changes
- Post for 30 days
- Members vote on renewal quorum must be met/minutes taken
- Majority vote
- Renewal done online at <u>www.utahpta.org/bylaws</u>

#### Amend

- Can be done anytime
- Committee suggests changes
- Changes posted for 30 days
- Members vote on the amendment – quorum/minutes
- 2/3 vote to amend
- Amendment info submitted at <u>www.utahpta.org/bylaws</u>
- Will receive new expiration date
